Unless you purchase a Static IP, you will be allocated a Dynamic IP address. AEE reserves the right to timeout inactive connections. Technical support may be limited to AEE broadband provided services, software and/or unmodified hardware. Bandwidth usage in excess of your package limit per month is considered to be more than normal usage. **AEE will charge an additional \$.015 per MB for Residential plans and \$.05 per MB for Business plans over the allotted amount of downloading usage. AEE reserves the right to change limits at any time without prior notice.**
